

## SIRIO IS PROVISIONALLY AWARDED THE CONCESSION OF THE BAR AND RESTAURANT SERVICE IN THE HOSPITAL COMPANY ""OSPEDALI RIUNITI MARCHE NORD",

## FOR THE MANAGEMENT OF TWO POINTS OF SALES AT THE FANO AND PESARO HOSPITALS

Ravenna, 21 November 2019 - Sirio SpA (AIM: SIO), an Italian company leader in the management of commercial catering in the hospital sector, announces that it has been provisionally awarded the concession for the management of the bar and restaurant service at the hospital company "Ospedali Riuniti Marche Nord".

The concession, with a duration of 5 years and a total value of approximately € 6 million as per tender specifications over 5 years, involves the management of 2 PoS: one at the Fano Hospital of approximately 80 square meters, and another at the Pesaro Hospital of approximately 140 square meters, for the cafeteria and bistro food service.

The service that will be provided by Sirio provides "good, clean and fair" food keeping and eye on the environment and sustainability, in addition to the diversified dietary requirements aligned with the Pesaro and Marche cultures with the presence of a healthy food offer.

The hospital company "Ospedali riuniti Marche Nord" is an Italian excellence for the diagnosis and treatment of cardiovascular diseases.

Sirio in both the Pesaro and Fano Hospitals will benefit from the collaboration with the BANCO ALIMENTARE MARCHE ONLUS with which it shares the inspiring values of the "Siticibo Project" for the destination of the unserved food. It provides for the recovery of food surpluses of cooked and fresh food and its transport and delivery at the end of each working day to the charitable facilities that assist the needy in the area.

Stefania Atzori, Sirio's Chief Executive Officer, commented: "By winning the tender at the 'Ospedali riuniti Marche Nord' hospital company, we not only confirm our already high level of tenders won, but we also reach a victory ratio of 100 % in 2019 in the hospital sector. But we do not want to stop, on the contrary, we consider this further assignment as a stimulus both to continue to improve and offer an increasingly efficient and humane service in hospitals, and to achieve the growth objectives that we have set for the coming years".
