

**SIRIO IS PROVISIONALLY AWARDED THE CONCESSION OF THE BAR SERVICE
AND CATERING FOR THE MANAGEMENT OF 1 POINT OF SALE AT THE
SAN LUIGI GONZAGA UNIVERSITY HOSPITAL COMPANY OF ORBASSANO (TO)**

Ravenna, 18 December 2019 – **Sirio S.p.A (AIM:SIO)**, an Italian company leader in the management of commercial catering in the hospital sector, announces that it has provisionally won the concession for the management of the bar and restaurant service at the University Hospital of Orbassano (TO).

The concession has a duration of 5 years with a possible 6 month extension and a total value of approximately € 6.7 million as per tender specifications in 5 years and provides for the management of 1 point of sales of approximately 320 sqm for the cafeteria service and bistro cuisine.

The service that will be provided by Sirio includes the insertion of a corner dedicated to pizza with the Alice Pizza brand (see Press Release 22 July), the cafeteria and restaurant with premium lines linked to the Piedmont region, as well as a line dedicated to health and wellness in collaboration with a nutritionist biologist.

The San Luigi Gonzaga University Hospital is characterized by medical-surgical activities that place it in a prominent position in the Piedmontese healthcare panorama.

Inside the hospital, the "Alessandro Bertinaria" Regional Anti-Doping Center, the Neuroscience Research Center of the recently inaugurated Cavalieri Ottolenghi Foundation, and the internationally recognized Microcythem Center, and present in the European Network for Rare Diseases, are highlighted.

Sirio was founded in 1993 in Ravenna as a professional operator in the commercial hospital catering sector, subsequently becoming its undisputed leader in Italy. Over the years, Sirio has expanded its areas of expertise, entering in 2006 commercial motorway catering, in 2012 in the fast food fast catering segment as franchisee of Burger King in Italy, in 2014 in the airport and finally, in 2018 in the City Center Business. As of December 31, 2018, Sirio is present in Italy with 77 points of sales at 31 December 2018, with a turnover of over € 64 million and over 700 employees.
