

**SIRIO IS PROVISIONALLY AWARDED THE CONCESSION OF THE BAR SERVICE
AT THE FATEBENEFRAPELLI HOSPITAL AND OPHTHALMIC CENTER,
OF THE MILANESE ASST FATEBENEFRAPELLI SACCO**

Ravenna, 16 March 2020 – **Sirio S.p.A (AIM:SIO)**, an Italian company leader in the management of commercial catering in the hospital sector, announces that it has provisionally won the concession for the management of the bar and restaurant service at the Fatebenefratelli Hospital and Ophthalmic Center of the Milanese ASST Fatebenefratelli Sacco.

The concession, with a duration of 5 years and an estimated contract value of approximately € 2.5 million, renewable for a further 4 years, provides for the management of a sales point of approximately 120 sqm for the cafeteria and bistro gastronomy service, and the market service.

The service that will be provided by Sirio provides an assortment of hot cafes complete with drinks from the typical Italian bar, and "healty" with particular attention paid to vegetarian / vegan customers and / or customers with particular food pathologies (gluten intolerant, lactose, diabetics) and a Market service for the sale of packaged food products including organic and fair trade products.

The Socio-Sanitary Territorial Company (ASST) Fatebenefratelli-Sacco is composed of 4 hospital wards and 26 territorial offices including the Fatebenefratelli Hospital and Ophthalmic center that offers highly specialized diagnostic, therapeutic and surgical assistance with focus on cataract, cornea, retina, ophthalmic plastic, and retinal diseases.

Stefania Atzori, CEO of Sirio, commented: *"The awarding at the Fatebenefratelli Hospital and Ophthalmic Center allows us to be present in Milan, along with the other two PoS managed within hospitals, as we want to continue to look to the future, because Italy and Italians don't stop. In this very difficult moment we would like to already be present so that we can put our solidarity and professionalism into practice to support doctors and nurses, the real heroes who are fighting courageously right now. "*
